# Turnover and Price Measurement

- SBS: Structural Business Statistics (annual turnover amongst other variables)
- STS: Short Term Statistics (turnover and prices) show short term economic trends
- Output measurement for Rental and Leasing of motor vehicles= turnover in most cases

# Turnover and Price Measurement

- Pricing unit of measure – mixed depending on the service being offered. Can be price per unit of time for duration of lease or price from list etc.
- Price methods implemented – a mix depending on the nature of service - pricing repeated services, contract pricing method, unit value method.
